Reminder of new COVID-19 requirement:

All churches to register for 'Check In Tas' app by 1 May





Click on "Register your premises or event". You need to complete a separate registration for each premises or event you operate. 2



Complete the registration form. You will be sent your welcome pack within 5 days of registering. 3



Clearly display your QR code at all your premises' or event's entrances.

- Every church, business and organisation in Tasmania in required to register in order to support rapid <u>contact tracing</u> if needed. Register your local church site now and create a QR code poster for your activities.
- Regular attenders and visitors can each 'check in' through one of four methods:
 - 1. Use the 'Check in Tas' app on their own smartphone.
 - 2. If a person does not have a smartphone or is unable to use one, others attending the premises with that person can use their own phone to check that person in.
 - 3. Alternatively, an organisation can register a person's details using that organisations' device.
 - 4. If there is no internet access or working device, the organisation can check them in manually on paper. This information must be retained by the organisation for 28 days or added into the app when access is restored.
- Churches still require a <u>COVID-19 Safety Plan</u> and density limits and physical distancing guidelines still apply.



Poker machines

Most readers will know that we presently have a State election pending in Tasmania. Whilst most people are OK with the policies of our various representatives and will exercise wisdom in seeking to vote for the best people to make up our parliament, we have one problem. Our major parties are "hooked" on gambling.

An interesting story is unfolding in the AFL where most clubs own poker machines to generate club revenue. A total of \$2.7 billion has been drawn into the coffers of League by this means, for year 2020 alone the sum was \$77 million of which \$24 million went to Hawthorn club. On the other hand North Melbourne has no poker machines and Collingwood, Geelong, Melbourne and Western Bulldogs are in various stages of divesting this business. This exists is in response to membership/community pressure, club members are saying, 'We do not want to be members of a club which operates poker machines'.

Voting Tasmanian citizens are members of this island community. NOW is an opportunity to tell our leaders, present and pending, to find another way, to do everything possible

to reduce the scourge of gambling in our state, to divest this revenue from the state income stream and to find ways to facilitate investment in productive enterprise.

Community pressure is making inroads in the AFL, it can work here too.

Gambling in Tasmania

From 2023 the Tasmanian Government's current exclusive license with the Federal Group expires, so a consultation process on government policy was initiated in 2020, to consider submissions on future policy in the gaming market. Various reforms, including increased future funding to improve harm minimization, are proposed.

The Uniting Church in Australia is a member of The Alliance for Gambling Reform, a collaboration of organisations with a shared concern about the deeply harmful and unfair impacts of gambling and its normalisation in Australian culture. The Alliance campaigns for reforms of the gambling industry that reduce the harm it causes. See https://www.pokiesplayyou.org.au/the_alliance.

The Uniting Church Synod of Victoria and Tasmania provided a submission, along with a number of companies and individuals including researcher and historian James Boyce, author of "Losing Streak: How Tasmania Was Gamed By The Gambling Industry" (published 2017 by Black Inc.). The Uniting Church submitted the view that electronic gaming machines (EGMs) should not be permitted in hotels and clubs after 2023 and should only be allowed in the two existing casinos, making them a form of gambling that is destination gambling, as that would significantly reduce gambling-related harm in Tasmania.

Submissions were received from 68 parties, providing feedback on the proposed Future Gaming Market regulatory model. A copy of the <u>Overview of Responses to the Future of Gaming in Tasmania Public Consultation Paper 2020</u> and copies of the individual submissions received are available online:

What can you do?

The upcoming Tasmanian election will be a historic one. Both major parties have come out with a gambling policy and are acknowledging the harm that pokies can cause to our communities.

- Labor has recognized that gambling harm is a serious public health issue and has pledged that if elected, they will remove pokies from pubs and clubs by 2023 with a funded scheme for a transition for businesses away from pokies.
- Liberal has announced that, if re-elected, they will be ending the Federal monopoly contract and allowing an open, competitive tender with 20-year pokies licenses being available for pubs and clubs to bid for.

An Epistle from the Tasmanian Council of Churches to Christians of Tasmania on the subject of Reconciliation with First Nations' Peoples.

Launceston, 20th of March 2021

The Tasmanian Council of Churches (TCC) is a fellowship of Christian Churches in Tasmania committed to the promotion of Christian dialogue and practical cooperation. In keeping with our mission, representatives met to learn from and share with each other our Churches' progress towards reconciliation with First Nations' Peoples. As a record of this meeting, we send this epistle - a combination of the insights and questions from our meeting that challenge us all to let our lives speak:

Makarrata* is a Yolngu word with many layers of meaning, describing a process of respectful truth-telling, listening, conflict resolution, peacemaking, and justice. It is entirely consistent with the teachings of the gospel and Christian beliefs about reconciliation. We can all learn from the process of Makarrata in our lives. What steps will we take to learn more about, and engage with, Makarrata?

There is a need for our Churches to place importance on the truth of the experiences of both past and present Tasmanian Aboriginal peoples. Denying or avoiding this truth only serves to take us away from our responsibility as disciples of Jesus. Will we stand firm with a commitment to respectful truth-telling, listening, conflict resolution, peacemaking, and justice if there are differences of perspective, or disagreement about the issues and their solutions?

Makarrata can be a faith-full activity of every disciple of Jesus Christ, not only for formal organisations and structures, yet some of our church

members relinquish responsibility for reconciliation and Makarrata to the leadership of their church as a way of avoiding taking individual action. How can we encourage and empower all to take individual responsibility for the process of Makarrata?

Some of our church congregations are enriched by their First Nations members. Some congregations have members who are on the journey of discovering their First Nations ancestry and what that means to their identity. However, many congregations have no First Nations members, or are unaware that they do. How do we ensure in both symbolic and practical ways that our places of worship are always welcoming to First Nations people?

Many Christians are unsure how to take the next step or even where to begin. Some are uncertain about the words to use, or fear that their intentions will be misinterpreted. For some, it is too hard or painful, and they retreat from the process altogether. Christian reconciliation is the idea of being made right with God and right with others and is an ongoing process. It is neither a once-off activity nor always easy. It is also what love requires. Do you have the courage to live your faith in the modern world?

"My song is love Love to the loveless shown And it goes on You don't have to be alone"


Chris Martin is the lead singer of the band and writer of this song. He comes from an English background.

What can worship leaders do to explore the fog? Are we able to find a pathway towards some of the connections between popular culture and the story of our faith?




COVID-19 reminder:

- Changes to gathering numbers at churches
- All churches to use 'Check In Tas' app

Tasmanian Public Health advises churches will be able to have more people in attendance under changes detailed at http://coronavirus.tas.gov.au/

- Indoor gatherings may now routinely accommodate up to 250 people or 75 per cent of their seating capacity in an indoor space, whichever is fewer.
- Churches still require a <u>COVID-19 Safety</u> <u>Plan</u> and <u>contact tracing</u> is required. Density limits and physical distancing guidelines still apply.
- From 1 May the <u>Check In TAS app</u> must be used to support rapid contact tracing if required. Register now to create a QR code for your local church.
- By 1 May 2021, you must clearly display the 'Check in Tas' QR code (sent to you after you've registered) at all entrances of your premises or event and all patrons aged 16 years and older must be checked in by scanning this code if they spend 15 minutes or more there.
- What if my participants do not want to use the QR code?
- If a person does not have a smartphone or is unable to use one, others attending the premises with that person can use their own phone to check that person in. Alternatively, an organisation can register a patron's details using that organisations' device. If there is no internet access or working device, the organisation can check them in manually on paper. This information must be retained by the organisation for 28 days
- My organisation operates at multiple premises. Do I need to set up multiple codes or can I use one for all of them?
- Each Check in TAS QR code is assigned to a physical address. If you operate at multiple premises or locations, you need to complete a separate registration for each site.


