The 16th Assembly is the triennial decision-making meeting of the national Council of the Uniting Church, which guides the life of the Church and its advocacy over the next three years. The 16th Assembly meeting will be reconvened from 6-9 May 2022 on the Sunshine Coast in Queensland.

The Uniting Church in Australia believes that we hear the voice of God through the councils of our Church, so time is also set aside for prayer, worship and Bible studies. Elected members come together to discern the guidance of the Holy Spirit in a meeting that encourages community and listening to one another in openness and humility. This Assembly will bring together 200 members from Synods and Presbyteries, with office holders, Uniting Aboriginal and Islander Christian Congress members, youthful members and others to form a national decision-making body.

# **Assembly meeting 2022**



Reports and proposals to the Sixteenth Assembly reconvened meeting are online: <a href="https://uniting.church/16thassemblyresources-2022/">https://uniting.church/16thassemblyresources-2022/</a>.

Significant proposals for discernment by the Assembly members include:

- a. Act2 On the Way requests the Assembly Standing Committee undertake a process to review the current 'interconciliar' model of governance of the Uniting Church; authorises the Assembly Standing Committee, following consultation with the Church, to provide guidance to the Church and amend the regulations relating to communities of faith to provide for more flexible and innovative local and digitally gathered communities of faith and discipleship formation; and request the Assembly Standing Committee to lead a national process with the Synods and other relevant councils and bodies to identify a new theological education framework in the context of developing the Uniting Church's theological culture.
- b. Continuing Witness proposes to approve the following documents for consideration by the Uniting Church between the 16th and 17th Assemblies, for reception as continuing witnesses: (a) The Confession of Belhar (South Africa, 1986); (b) Laudato si' (Papal Encyclical, 2015), and (c) The Joint Declaration on the Doctrine of Justification (Catholic Church and World Lutheran Federation, 1999). The process of consideration would involve an invitation for all Presbyteries within the Church, and such other Councils of the Church as desire to participate, to commit to discussing each document for a period of at least one hour, using resource materials provided by the Continuing Witness Task Group, and reporting the results of this discussion to the Task Group.
- **c. Regulations on Discipline** proposes to delegate to the Assembly Standing Committee the authority to make Regulations under Part 5 of the Regulations (Church Discipline), to manage the complaints and discipline processes within the Church, subject to a framework of principles, and advice from the Assembly Legal Reference Committee.
- d. A call to action for climate justice: listening to First Peoples wisdom, which commits anew to listen to First Peoples wisdom and knowledge, and to take practical climate action including changing our own behaviour, and to call on all Councils of the church, agencies and schools who have not already done so to join with the Assembly in committing to net zero emissions by 2040 at the latest, so that together we can become a zero emissions Church. Proposed by Alison Overeem.

- **e. Audit of small congregation financial statements** proposes to authorise the Assembly Standing Committee to amend Regulation 3.8.7(e), Variations to Qualifications, from 2.5 times the notional stipend to the Australian Charities and Not-for-profits Commission (ACNC) financial reporting revenue threshold for small charities.
- f. Preventing Harm from Sexual Orientation & Gender Identity Change Efforts (SOGICE) proposes that the Assembly recognise that sexual orientation and gender identity change efforts (SOGICE) are harmful to people's mental health and wellbeing, and request the Assembly Standing Committee to develop a process to provide a national resource for congregations, agencies, and individuals to learn how they can help prevent harm from SOGICE ideology and practice.
- **g. Moving Forward in Being a Multicultural Church** proposes to request the Assembly Standing Committee, liaising with other parts of the Church, to move towards simpler, friendlier, and more equitable church structures, processes, and ways of working that foster CALD participation and intercultural partnership by reviewing the national property policy for the UCA, and reviewing the regulations relating to Faith Communities, and produce guidelines for receiving/recognising Faith Communities/Congregations from other CALD churches.



#### Background on "Nakba"


