## Faithful Futures



We are hearing a whole lot about “*Faithful Futures*” at the moment. What is it, what isn’t it, will this impact me in my corner of the church and a myriad of other questions. This short article will give some outline and encourage you to follow and engage with Faithful Futures.

Faithful Futures is a combined project, 18 months in development. At the Synod meeting in August this year proposals will be presented to bring the project to life, having first been endorsed by all eight presbyteries. Based around the Synod vision statement of “Following Christ, walking together as First and Second Peoples, seeking community, compassion and justice for all creation”.

Goals and dates are still to be confirmed by Presbyteries and the Synod meeting in August 2025

**Coordinated Ministries (2030)** – “looks to strengthen and/or develop mission into geographical areas, whilst remaining attentive to the needs of the local context.” The Presbytery of Tasmania has for some time been considering what coordinated ministries might be and have already begun to rethink ministry.

**Respecting Country (2028)** – “looks to encourage all communities of faith to be able to tell the story of the Country on which they are located. There are many ways to hear and share stories and build relationships with local Traditional Owners.” The Presbytery of Tasmania continues to develop a listening posture with UAICC Tas and build connections around the presbytery.


**Intercultural Leadership (2028)** – “to provide appropriate formation and equipping leaders from different cultural groups alongside developing networks to support worship, witness and service among communities of diverse languages and cultures”

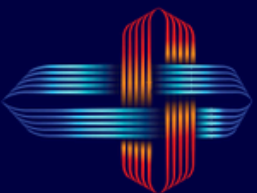
## Ancient Futures

# Presbytery Meeting Saturday 31 May by Zoom

**Members of Presbytery and others interested as visitors are invited to the next Presbytery meeting on Saturday 31 May (the last day of Autumn!).**

To reduce the burden of travel, as the days get colder and shorter with the brumal clime, this meeting will be held via Zoom.

Attendees can either gather in groups or join on their own but are asked to contact the Presbytery office (ph. (03) 6331 9784, email: [tas.office@victas.uca.org.au](mailto:tas.office@victas.uca.org.au)) by Wednesday 28 May if possible to confirm attendance or notify apologies or alternates.

A test run zoom meeting was held on Wednesday 14 May, which offered some learnings, including that we are asking attendees to connect at 9:30 am to ensure the technology is working prior to the start of the meeting at 10:00 am.

Meeting remotely offers connections that are otherwise not possible, as I note that our Presbytery Secretary, Shirley, who is leading devotions, will be joining this meeting from outback Queensland. As ever, the meeting is intended to share what's happening in the life of the local congregations, within the Presbytery and in the wider church, to encourage and strengthen one another's faith as well as discern our mission and ministry on the way, so attendees are encouraged to share what's happening in their local area.

In our reflection on the Basis of Union, the focus is the continuing witnesses aspect of Section 11, where we learn from the wider church, as Marian will give an introduction to the Reformed Churches' Belhar Confession, which grew out of the need to confront the sin of racial segregation.

Lunch will be self-catered, with an encouragement to share together where you can, and for amusement pictures of your food can be shared, with a virtual prize (and the envy of others) for the best lunch.

A key focus of this meeting is the "Faithful Futures Project", following the participation of Rohan, Marian and Shirley's participation in the VicTas Synod gathering in March.

More information will be given over the coming months, but this is a project for the church to focus on shaping our future mission and ministry, that invites us all to see how we can share the abiding love of God in a rapidly changing world.

# Marian's Musings



**“...who cries for them.”**

It is hard to go past the election at this moment in time. Australia faced a choice which became hugely important which way the country would speak. And they did, clearly, loudly and with a mandate to hold government to a higher standard than we are seeing around the world.

Does the loud voice cease to shout now it is all over, and the results are beyond doubt? Does the responsibility of every one of us to continue to stand up and shout out for what is just, for what is fair and importantly to be the 'annoying voice' when things are far from right or just?

First Nations people remain at tangible disadvantages, who cries for them?

LGBTQIA+ people face growing discrimination, who cries for them?

Refugees and Asylum Seekers remain unwelcome, who cries for them?

I remember very clearly one of the first decisions Pope Francis took was to not wear the papal red shoes and to wear his own shoes. He was clear throughout his papacy that people mattered and as much as the role allowed this has been the mark of his papacy.

Pentecost is four weeks away, as I write this and every year I wonder the same thing, in what way do the celebrations of Pentecost and the cries of *veni sancte spiritus* (Come Holy Spirit) engender a change of heart, a time of sitting silently in the noise to see the small still voice of God around and in all.

As the noise of the election fades and is replaced with the busyness of life and work we are still the ones who cry out at injustice and unfairness.

# Faithful Futures (cont)

**All-Age Growth (2030)** – “to have one all age community of faith which is interactive, diverse and inclusive in at least 80% of Coordinated Ministries.” The presbytery of Tasmania has small groups which engage with Messy Church, Godly Play, but some other ways might include digital/online communities of faith, laundry cafes, Labyrinth walks, connections with childcare and aged care facilities.

Some final points:

Faithful Futures developed following Presbytery Ministers advocating to the Synod that something had to change; presbyteries were and continue to groan under the ever-increasing requirements and ever decreasing numbers of faithful followers.

The four goals are not intended to replace existing ministry; rather they invite us to explore the ways communities of faith continue to be present in the wider community. Finally, Faithful Futures has been considered in the light of the proposed changes under Act2 and works alongside it, whilst separate from it.

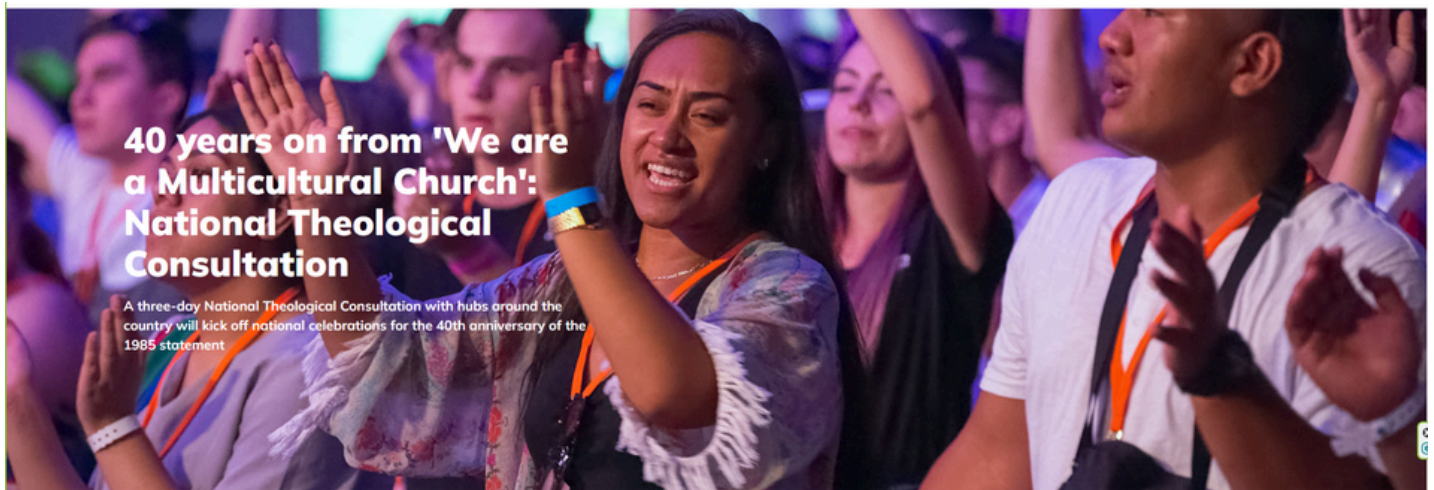

## 40th Anniversary of the 1985 'The Uniting Church is a Multicultural Church' Statement National Theological Consultation: 10–12 June 2025

2025 marks the 40th anniversary of the Uniting Church Assembly's 1985 declaration, 'The Uniting Church is a Multicultural Church.'

To mark this significant occasion, a three-day National Theological Consultation will be held from 10–12 June, co-organised and co-hosted by the Assembly, United Theological College, and NSW–ACT Synod Intercultural Ministry. The event, with the theme Being a Multicultural Church: Forty Years On, will be held at United Theological College with online streaming and hubs around the country.

### **The program**

Tuesday 10th June: Being a Multicultural Church: Forty Years On — Reflection on the Declaration

25 speakers around the country, from people who witnessed the declaration to those who travel on this journey, share their insights and reflections.

Wednesday 11th June: "Living Cross-culturally as a Multicultural, Intercultural Church" — A Theological Reflection for the Present Time

Four papers contributed by academics and practitioners are presented and then followed by conversation and discussion. Those papers examine the topic through biblical, theological, historical, and praxic lenses.

## *Faithful Futures recommendations*

Following Christ, walking together as First and Second Peoples, seeking community, compassion and justice for all creation.

### Coordinated Ministries

Coordinated ministry and mission in geographic areas such as Local Government Areas, attentive to the life and needs of the local context, by 2030.

### Respecting Country

All communities of faith will be able to tell some of the story of the Country on which they are located by the end of 2028, and be invited to develop local and appropriate ways to respond.

### Intercultural Leadership

By 2028, to:

- (a) be providing appropriate formation and equipping for leaders of different cultural groups; and
- (b) develop networks to support worship, witness and service among communities of diverse languages and cultures.

### All-age Growth

To have at least one all-age community of faith that is interactive, diverse, inclusive and transformative in 80% of Coordinated Ministries by 2030.



The Uniting Church is called to be a pilgrim people, participating in the movement of God. Presbyteries and the Synod have been engaging in a "Faithful Futures" Project discerning ministry and mission ahead. The VISION is widely recognised.

Each presbytery is invited to consider the VALUES that guide their approach to ministry and mission. The GOALS have been developed through Bible study, survey, prayer and consultation. The Faithful Futures Project Meeting on 21 March 2025 resolved to recommend this Vision and these Goals to the presbyteries across Victoria and Tasmania, and to the Synod. Shared goals will help to relieve burdens and strengthen new mission opportunities as we follow Christ together.

## Faithful Futures Steering Committee

Including a member from each presbytery, to oversee the work and identify progress, stories and challenges around the presbyteries.

### **Faithful Futures Project Lead**

Providing leadership, working with the Steering Committee and Goal-focused groups.

## Principles

- 1** The faithful Futures goals are the shared strategic priorities of presbyteries and the Synod. Implementation responsibilities are shared between presbyteries and the Synod.
- 2** All groups to have clear accountability and lines of reporting.
- 3** Outcomes need to be measurable, financially sustainable, and requiring suitable criteria to be developed and working with the Congregational Insights report developers.
- 4** Effective communications throughout presbyteries and the Synod.

# Tasmanian Presbytery Committees

## – Presbytery Standing Committee

These notes are to inform church members on how the committees within the Presbytery work. The Uniting Church regulations specify (Reg 3.7.2 (a)) that the Presbytery formally establish three committees to carry out the relevant activities:

- (i) a Standing Committee; (PSC)
  - (ii) a Pastoral Relations Committee; (PRC) (dealing with ministry and pastoral issues.)
  - (iii) a Property Committee; aka Resource Development Committee (RDC) (dealing with property).
- In addition the Presbytery may also establish Task Groups to attend to specific functions.

The following is to give some details about the Standing Committee.

As outlined on the Presbytery webpage:

The Presbytery Standing Committee responsibilities are:

- priority setting and making recommendations to Presbytery
- establishing task groups to do defined tasks
- establishing and organising the agenda of Presbytery gatherings to ensure timely discussion of issues and encourage participation
- act, when necessary, between meetings of the presbytery.

(This means decisions that have to be made before the next presbytery meeting, or referred by Presbytery, are made by PSC and reported to Presbytery.)

Currently the Presbytery Standing Committee meets monthly, usually on the fourth Thursday of each month from about 10:00 am to 3:00 pm, sometimes in person but often by zoom.

The current membership of the PSC includes: Ricky Beswick (Presbytery Chairperson), Shirley Bowers (Presbytery Secretary), George Kogios (Presbytery Treasurer), Chris Duxbury (PRC Chairperson), Geoffrey Howells (RDC Chairperson), Marian Bisset (PM North and eLM), Rohan Pryor (Synod Liaison Minister and PM team leader), Helen Geard, and Scott Parkes.

In its discussions and follow up activities, PSC like the Presbytery and the other committees rely heavily on the expertise and efforts of the Presbytery staff, as well as input from the wider church. The agenda generally includes reports from the Presbytery staff, usually highlighting specific congregational or other needs, planning Presbytery meetings and other Presbytery events as well as considering our interactions with the wider church. One of the key issues over the next months will be considering the Faithful Futures project, as the Synod and Presbyteries look at our future mission and ministry, and work together on common projects and strategies for the future.

If anyone is interested in potentially serving on one of the committees, please speak to one of the Presbytery leaders. To broaden the representation on the committees, representation from the North West area and from younger members would be particularly appreciated.

Please confirm your attendance at one of the sessions by sending an email to [TAS.OFFICE@victas.uca.org.au](mailto:TAS.OFFICE@victas.uca.org.au) by Friday 16th May to ensure there will be sufficient booklets for all attendees either in person or online. You will need to supply an email address for the certificate to be sent to. The certificate comes from the Synod and is also the means to record who has completed the training. This will also prompt a reminder in 3 years to renew the training.

The current UCA policy states:

*This Policy applies to all entities and individuals associated with the Uniting Church in Australia – Synod of Victoria and Tasmania who engage in child related services or activities. Entities of the Church include, but are not limited to: Congregations, Presbyteries, agencies, ministries, childcare services, out-of-home care services, family and community services, disability services, health services, camps and schools. It will be implemented by board/council members, employees, volunteers, children, parents, carers, presbytery members, church council members, elders, congregation members, people in the specified ministries of the Church, and any other person with responsibility for the care of children.*

Simply put, any form of leadership from flower roster people, organist, committee member, worship leaders need to have completed the Safe Church Training. This forms part of the compliance aspect of the Presbytery and Synod.

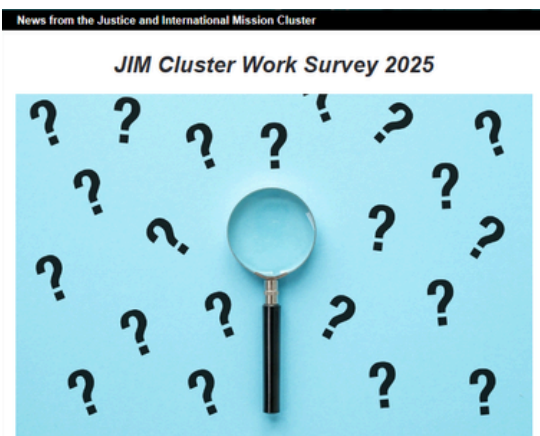
## Standing Together, Cooking Together

# Christian Community and the pursuit of Common Good

## Justice and International Mission Convention 2025

*Do nothing out of selfish ambition or vain conceit. Rather, in humility value others above yourselves, not looking to your own interests but each of you to the interests of the others.*

**Philippians 2:3-4**

When Jesus said, "Whatever you do for the least of these, you do for me," (Mt 25:40) he was inviting us to seek the Common Good. Jesus saw a common good as fulfilling God's will that we love and serve others, creating a society where all people are valued and treated with dignity, and where justice and peace prevail. The common good is a collective responsibility, where people live in harmony, sharing resources, offering help, and showing kindness to one another in ways that build up the community, and not just for individual gain.

Political and financial inequality across the globe and in Australia is increasing, resulting in people on lower incomes believing that the democratic system does not work for them. The increase in these inequalities also erodes trust and social cohesion in our society, and increase the growth in racism. It also makes it harder to address problems that require whole of society and international cooperation, such as climate change and pandemics.

The problem of the erosion of trust and social cohesion is enhanced by the spread of disinformation and misinformation in the online world. The ability of generative artificial intelligence to create realistic video material will increasingly make it more difficult to tell the truth from lies in the online world.

The Convention will examine what we, in the Christian community, can do to reverse these trends and rebuild a commitment to the common good in our society.
